Many people that are direct experiencers have reported different types of Grey Aliens over the past 100 years.

What Happened to Granger Taylor



Granger Taylor was a genius. Born in 1948, he grew up on Vancouver Island, British Columbia, Canada and was considered a self taught person. November 29th 1980, Granger disappeared and was the subject to many who were interested in finding out what had happened. That night he walked out of his parents home, leaving behind a note leaving all his valuables and money to his parents. He explained that he was going to board an alien spacecraft where he would go on a trip around the universe on a 3-1/2 year journey and that he would return with information. A hand-drawn map of Waterloo Mountain was sketched on the back of goodbye note.

The note read: "Dear mother and father, I have gone away to walk aboard on an alien ship as recurring dreams of a 42 month interstellar voyage to explore the vast universe then return. I am leaving behind all of my possessions to you as I will no longer require the use of any. Please use the instructions in my will as a guide to help.

Love Granger" On his will he scratched out all the words of deceased and wrote departed.

Four decades later, Granger's story is so amazing it deserves to be told. Granger Taylor was born October 7th 1948 in Duncan, British Columbia, Canada. His father drowned in an accident on a lake when he was a young boy. Granger would then spend lots of time alone in his bedroom. He dropped out of school in 8th grade. He had a knack for taking things apart and putting them back together and was a naturally talented mechanic. He went on to build various vehicles. At age 14, he built a cylinder car. At age 17, he built a walking bulldozer. In 1969, in his 20s he spent two years restoring an old locomotive that he found.

The locals began to dub the farm, Sleepy Hollow Museum. After mastering machinery, Granger turned his attention to the skies. He got his pilot license. He began getting interested in UFOs. He wanted to learn what he could about beyond the realm of human existence. He constructed in his backyard a life size UFO Craft that he turned into his home away from home. He had a large collection of a life time of eye-witness accounts of UFOs and people who claimed they know secrets of their abilities.


In 1969, Cowichan District Hospital, 3 nurses claimed to have seen a large Saturn shaped UFO hovering in the sky 60 feet from their window. Sightings began to be seen by many. Granger claimed that something reached out to him and received a message from beyond the stars and been contacted telepathically by aliens, and heard voices in his mind. He had many more conversations as time passed, and he asked many questions. In October 1980, Granger announced that he has been invited on a trip through the galaxy.

On month later on November 29th 1980, there was a severe storm warning. At 6pm he walked into a grill shop. He paid his bill and left at 6:30pm. Linda would be the last person to ever see him alive. That night he drove off and never returned. This same day was when his step father found his note. Theories of what happened to Granger Taylor begin to take place, What happened to Granger Taylor?

Did Granger decide to take his own life? If so where is the body? Did he fake his own death?

In 1986, a place was found on Mount Prevost, near Duncan, where some explosion had occurred several years earlier. And in its center were found the bones of an unknown man. Unfortunately, DNA tests in those years were not yet so common but the coroner for bone analysis concluded that the deceased was of the same age, sex, race, and height as Granger Taylor. A piece of cloth among the bones was very similar in pattern to Taylor's favorite shirt. Next to the bones were found the remains of a truck and it was identified as similar to the Taylor pickup. Thus, the Taylor case was officially closed. Granger Taylor, 32, was officially declared dead as of Nov. 30, 1980.

However, many of Taylor's friends did not agree with this. They are confident that the police's findings are only indirect and their friend either stayed in space or was abducted by the US government. Taylor's best friend, Robert Keller says that the police worked very carelessly and that they wrote that the remains of the truck found on the mountain are Taylor's blue pickup truck. However, Keller assures that the Taylor pickup was not at all blue but with pink stripes. Many dug deeper into Taylor's life but ultimately fails to draw any conclusions about his fate. The Mystery remains, what happened to Granger Taylor the night of November 29th 1980, the world may never know.



Men in Black



1947 is considered by many to be the year in which the modern UFO age started, due mainly to two reported events which supposedly took place that year. In June, Kenneth Arnold was to report seeing a number of metallic craft while flying near Mount Rainier in Washington state, and within a month, a craft was said to have crashed on a ranch in Roswell, New Mexico.

However, another incident took place allegedly before Roswell that kicked off another facet of UFO folklore. The mysterious Men In Black. We will touch on it very lightly here but a man by the name of Harold Dahl reported in 1947 that while scavenging for drifting logs, he saw 5 to 6 doughnut shaped objects fly over his boat near an island near Washington. One seemed to be malfunctioning and ejected some metallic-like debris all over his boat which injured his son and killed his dog.

He claims the next morning a strange-looking man, dressed in a black suit, appeared at his door and invited him for breakfast at a nearby diner. Even though Dahl had not told many people about the incident, the man who was assumed to be a military or government representative, disclosed while they ate, details about what had happened the previous day, and made a veiled threat against his family if Dahl were to talk about what he had seen.

The Maury Island Incident is now considered to be a hoax, as Dahl has claimed before his death that the story was made up but then said the story was true. He had claimed it was false due to fears regarding the safety of his family. Whether the story was true or not, people soon afterwards began claiming similar stories, and over time these stories started to become very bizarre.

Since the 1950s many UFO eyewitnesses have made claims of men visiting them soon after seeing a light or object in the sky, sometimes driving out of date black cars, and their behavior has been downright disturbing and odd. In most cases, it is implied that the witness should not discuss publicly what they saw, and have been known to confiscate photos or any kind of material evidence supporting a sighting claim.

Many conspiracy theorists believe they are covert government agents who are part of a wider conspiracy to suppress public knowledge of the existence of extraterrestrials or UFOs, and perhaps appear to intimidate and instil fear in a witness to make them doubt what they saw or to take the focus away from the sighting by appearing and behaving strangely.

So who or what are these dark-clothed men?

Nobody knows for sure but many theories have been put forth over the decades. It has been suggested since the early 1960s that the M.I.B. or the Silencers are in fact themselves extraterrestrial in origin or possibly even alien-human hybrids whose agenda possibly is to control and manipulate eyewitnesses into keeping quiet about what they have or might have observed. The fact that in almost every story that they appear and know about the sighting before witnesses have disclosed anything to others may support this theory.

Also, the fact that they seem to act and speak in a bizarre fashion may also point to that conclusion with some being seen to be wearing wigs, make-up and sometimes prosthetics. Their speech is sometimes slurred, uneven in tone, and sometimes it seems to be an attempt to put on an accent with comical results. More sinister reports are of two or more M.I.B. appearing at the foot of ones bed in the morning or at night with glowing eyes, and smelling of sulphur or brimstone. Are they supernatural in origin?

History is full of encounters with men dressed in black that have religious connotations that many regarded as encounters with the Devil or his minions. Could these beings be using religious myths to frighten UFO observers in an Christian-entrenched society?

A similar theory is that they are robots or androids operating on a kind of artificial intelligence, programmed to enforce a code of silence who may have been created by some of the governments of the world who are in league with extraterrestrial beings. Another theory is that professional actors are employed to play these sinister figures to possibly deflect attention away from the UFO situation by creating a whole new character or entity to be feared of.

Who employs them to confuse and befuddle innocent citizens is a matter of debate, although many believe it is the Military, Air Force or a possible secret intelligence group who are still today orchestrating a major cover-up relating to the existence of extraterrestrial life and their crafts and technology.

It is now known that in the early decades of the UFO era, many people associated with UFO research and investigation were befriended by agents from the government to keep a watch over and possibly control or manipulate the information circulating around concerning aerial phenomena and UFOs with original UFO civilian groups also being infiltrated as well.

Is the M.I.B. phenomena a more sinister way for whomever to get their point across?

There have been rare accounts of M.I.B. actually physically harming or killing someone but there are some reports of this nature which seem to indicate that they mean business and should be taken seriously. Whatever these people are, stories still abound to this day of visits from Men In Black, and in popular culture of course we have a series of comic books, an animated TV show and three motion pictures starring Will Smith that gives us the idea that yes, these men are human agents who work for a secret organization whose task it is to control and monitor not only what humans see and experience in regards to extraterrestrial life but also police extraterrestrial beings on Earth and save us and our planet from potential threats.

The Allagash Waterway Abduction



The Allagash Waterway Abduction or The Case of the Allagash Four is one of the world's most famous, and terrifyingly vivid, eye-witness accounts of alien abduction.

What separates the Allagash Four's story from other eyewitness cases is that they are not only witness to alien abduction, according to the men, they were also all the victims of the very same abduction.

In August of 1976, brothers Jim and Jack Wiener, along with their best friends Chuck Rak and Charlie Foltz headed on a

sportsmen's trip to the Allagash Waterway to relax in the time between finishing college and beginning their new careers. The four had all graduated from the Massachusetts College of Art. Their trip to Allagash would certainly be remembered but not for reasons they had planned.

They camped by Eagle Lake, and one night decided that with rations running low, they would do well to attempt some night fishing. The four paddled out onto the lake after setting up a very large and bright campfire on the banks to work as a landmark so they would be able to find their way back to camp.

After some time on the lake, all four of the men report that they caught sight of an enormous light that was moving into the sky. They described it as impossibly bright, brighter than a star. It was hovering over a grouping of trees a few hundred yards away. The light reportedly burned red, then changed to green, and then yellow. The massive object is estimated to have been about 80 feet in diameter.

The light began moving from its position over the trees, and along the bank toward the group. Foltz, meaning well, flashed an SOS signal at the light in the sky using his flashlight. This triggered the massive floating light to begin moving steadily toward the four men in the tiny canoe.

This curiosity they had had now turned to abject panic and fear as the four made an attempt to rapidly paddle back to shore. The men were engulfed by the light, and then they were standing on the water's edge again. They knew they had not finished paddling their canoe back to shore. All they could remember was fleeing from that bright light, and then standing there together like nothing had happened. The object was still in their sight, and Charlie flashed his light at the object again only to see it move upward and then disappear into the night sky.

The men were curious about what had happened to them. They returned to camp to see that their bright landmark bonfire has smoldered down to nothing but ashes. This would have taken hours, as the fire was well-fueled, and very large and healthy when they had left. It had been perfectly visible from out on the water.

They said very little as they packed up their gear and supplies, headed home, and resumed the day to day grind of their new careers. They had no idea what a profound effect that night would have on the rest of their lives.

Jack Wiener was the first of the four to start suffering from vivid nightmares. In his dreams, he could see long-necked, large-headed bipedal beings surrounding him and examining his arms. They would scrape cells from his skin while his three companions, Jim, Chuck and Charlie all sat some distance away and quietly observed. The beings in Jack's dreams had huge, lidless eyes and insect-like hands.

In 1988, out of curiosity, Jim Weiner attended a UFO conference hosted by Raymond Fowler. Fowler was excited to hear this story, especially given that it was an account with multiple present eye-witnesses. Raymond Fowler suggested that Jim and his three companions should all undergo regressive hypnosis because all four of them had been having the same vivid, terrifying nightmares since the event.

After the sessions, it was revealed that all four of the men had been abducted, and subjected to humiliating physical examinations including the taking of skin and fluid samples. All four gave alike descriptions of their alien abductors, and being trained artists, were able to accompany their stories with detailed drawings which showed consistencies between their experiences.

They all corroborated their stories. They had similar descriptions of a color changing floating light, the appearance of the aliens aboard the craft, their treatment by said aliens, and the physical atmosphere in what they believe was an examination room. They described the room they were held in as being very similar to a vet's office. Chuck Rak also noted one strange thing: He had had difficulty focusing on the aliens themselves. Whenever he tried, his mind would go fuzzy and loose focus. He compared it to trying to tune in a fuzzy radio station.



After the psychiatric examinations, all four of the men were deemed to be mentally stable, and they all passed lie-detector tests. It is certain, given the circumstances these four men have gone through, that something happened that night. Jack and Jim Wiener, Charlie Fultz, and Chuck Rak, all encountered something they could not explain, something out of this world that night on the Allagash Waterway in 1976.

Crop Circles



These crop circles began being reported in the 1970s by farmers in their fields throughout southern England but before long reports came in from all over the world.

After reports of strange lights in the sky around fields began being reported. Many started to believe that these flattened, mostly circular formations were being created by UFOs and their inhabitants.

It is a phenomenon that has been occurring for centuries. With it possibly being depicted in drawings made by Aborigines from thousands of years ago, and has had the scientific community in debate over the last forty years. It is shrouded in controversy and mystery, as many skeptics now believe the enigma known as crop circles, areas of flattened crop found in fields throughout numerous countries in the world, are a man-made phenomena that were created by hoaxers and their copycats. However, there is much more to this conundrum than simply being the result of pranksters, with many still believing that there may be a supernatural cause or perhaps even being caused by a meteorological abnormality.

These circles began being reported in the 1970s by farmers in their fields throughout southern England. Although, historians have found documentation said to show that the patterns have been occurring for decades, debunking the perception that this is a modern phenomena. At first they were singular, circular or egg-shaped depressions found in everything from fields of wheat, maize, barley and other cereals to rapeseed, sugar cane and reeds. They would be found during the daytime, and appeared to have formed overnight.

After reports of strange lights in the sky around fields began being reported, many started to believe that these flattened formations were being created by UFOs and their inhabitants. Many religious and superstitious folk began sprouting the belief that the Devil had been creating the circles, fueled perhaps by ancient folklore regarding a curse created by a scorned farmer who refused to pay a worker more money for reaping his crops. Many believed that the shapes were created by nature spirits, such as elves and Fairies, trying to communicate with humans.

However, in September 1991 a pair of professional pranksters by the names of Doug Bower and Dave Chorley came forward and claimed a reward of 10,000 pounds from the media, openly confessing that since 1978, they had been responsible for most, if not all of the crop circles found throughout

England, in the summers up until that time, and had used simple tools such as rope, surveying tape and planks of wood to create the circles.

It is claimed they came forward after a number of scientists began claiming these circles couldn't be man-made. They are said to have created a simple circle in front of a group of journalists and paranormal investigators, and Bower admitted the idea started from an incident he had heard about while living in Australia in the 1960s, in which a man had claimed to have seen a UFO flying away from grassland in Tully, Queensland, and had left a circular nest in swamp grass.

By this point, many scientists believed the circles were the result of rare meteorological events such as freak tornadoes or whirlwinds that were somehow affected by nearby hills. However, this theory was dealt a blow when formations were found with straight lines between circles, and smaller circles or lines crossing or mixed with them. Then more elaborate designs were discovered, stretching miles in length and width and displaying pictures of animals, intricate geometric and complex shapes, astrological signs, and magic symbols.

After the confessions of the two UK pranksters, many people believed that the whole subject was a hoax, and that copycats were emerging and creating the newly found, more sophisticated crop formations. The case seemed to be closed on the subject, however, there are today people who are convinced that the crop circle phenomena is not entirely a case of human artistry and tomfoolery. With many claiming since the late 1990s to have witnessed these formations, whether simple or complex in design appear in minutes or even seconds right in front of them, seemingly created by the hands of an invisible force or forces!

While it cannot be denied that many of these patterns and designs are the work of humans, with some being created for companies and corporations to advertise themselves. There are a large number of formations that can't be easily filed under human handiwork. With some designs having up to two thousand circles or shapes in their design alone. Many have questioned if the more elaborate designs are in fact being made by perhaps something out of this world rather than humans, as some have appeared overnight and even during the daylight hours after the area has been visited. It has been proven that a simple dumbbell design, in which two circles are linked by a line between them, can take up to twelve hours to create by human hands in darkness.

Also, many have asked why many of the pattern formations don't seem to show any kind of trail from hoaxers accessing the fields, as many of the later formations were found no-where near roads or tracks, unlike the original singular circles. And could Bower and Chorley easily explain the now mounting evidence of formations being made all over the world, many of them being recorded prior to 1978?

There is evidence that in some cases, UFOs may be involved with many unexplained lights being seen and then afterwards formations are found. In some cases, especially in the U.S. the discovery of crop circles have been made around the same time and area of cattle and animal mutilations. There is also many sightings of small orbs near newly formed formations, leading many to speculate the existence of Fey folk and their involvement.

With this topic frustrating many researchers and scientists still today, what many agree on is that many hoaxers are responsible for many of the patterns and pictographs found. There is evidence however that not all cases are the result of compressed plants and that some kind of external, large heat source is creating them.

What was the Roswell Incident?



The Roswell UFO Incident took place in 1947, and is well known all around the world. It was the crash landing of a supposed US Air Force surveillance balloon or a weather balloon, which landed in Roswell, New Mexico.

The UFO, or surveillance balloon crashed near a Ranch owned by the Proctors. Mrs. Proctor said that when the debris of the object was discovered, she remembers how strange the material was. They believed that it was the wreckage of a UFO, and that they should report it. William Brazel, the man who originally discovered the wreckage, reported it to the Roswell Army Air Field.

It is believed that military radar had been tracking an unidentified flying object across New Mexico for four days, and then it went off radar around the northwest of Roswell right where the wreckage was found.

When press heard of the incident and turned up at the scene, along with military agents, they were shown debris such as foil, wood, and rubber, which were supposedly taken from the area of the crash, to prompt the idea that it was simply a weather balloon crash and effectively cover up the truth. The story was constantly being changed by the government, and since then, we've never been given a complete story.

It is reported that bodies had been found at the site and were taken away by the military to the Area 51 airbase to have autopsies but these claims have no evidence strong enough to make them credible. It was released over 40 years after the crash that the supposed aliens that people saw were actually life-size dummies which were being used in a government experiment.

Years later, military personnel who were there at the scene of the crash came forward to tell the truth, sparking the interest of conspiracy theorists once again. It is claimed that the debris clearly did not come from a balloon of any kind. There were alleged hieroglyphic symbols on the metal, and it was paper-like and lightweight but stronger than any other metals.

A photographer, who was apparently asked to photograph the incident, was taken to a closed off area of the crash site and saw the bodies of 4 very alien-looking creatures laid out. He was then told to forget that he ever saw anything.

Just when the hype was about to die down, Lieutenant Walter Haut, the man who originally gave the weather balloon statement, confirmed that it was all just a cover up story. In 2005, right before his death, he told the world that the Roswell Incident was actually the crash-landing of a UFO, and that he'd seen the bodies of aliens during the clearing up of the site. In my opinion, the statement of this man is more credible than anything that the government tried to tell us.

1952, Salem Massachusetts UFO Photo



On July 16, 1952 at 09:35 AM Coast Guard seaman Shell Alpert took this picture of four roughly elliptical blobs of light in formation through the window of his photographic laboratory. The objects were also witnessed by Coastguardsman Thomas Flaherty. Both were assigned to the base in nearby Salem, Massachusetts. The first analysis by US Air Force's Project Blue Book concluded it was probably a double exposure hoax. A second analysis by Blue Book concluded that it was probably reflections of street lamps on a window. Finally, the case was considered unexplained by Project Blue Book.

President Carter's UFO Experience



While many seem to think that UFOs are only seen by the insane or those who cannot identify objects in the sky, the truth is that many people with good reputations, and a good amount of honesty have seen strange objects as well. In fact, before he even came into power, one of the presidents of the United States witnessed something he could not explain, despite his good knowledge of science and astronomy. While President Carter, the main witness to the event, does not think it was an alien craft, he admitted often that he had no idea what it could have been instead.

In 1969, Jimmy Carter, then not even Governor, was preparing to give a speech to the Lions Club meeting he was attending one evening. However, another guest brought his attention to an odd, bright light in the sky, visible somewhat over the horizon. The object seemed to be about the same brightness as the moon, giving it a vivid cast. Carter reports that the object then seemed to draw in for an approach, stopping behind a grove of pine trees. It then changed colors between blue, red, and white before vanishing once again into the distance. While the object was clearly giving off light, Carter said he saw no solid aspect to it, instead just viewing its luminescence. Other witnesses of the event had much less clearer recollections of it, mostly just remembering it as an unusually bright point that might have been a weather balloon catching light.

In the years that followed, Carter, while holding steadfast to the idea that it was not an alien craft, failed to find an explanation that satisfied him. He doubted that it could be a military craft because it made none of the noises he would have expected from a helicopter. Some suggested that it might have been Venus giving off an aura or twinkling but Carter dismissed this as well, pointing to his study of astronomy and his good grip on Venus' appearance. Once he became president, he also added that none of the CIA or anyone else knew anything about alien invaders, denying rumors that the information had been kept secret even from him.

Interestingly, while Carter seemed changed by the event at first, promising full disclosure on all UFO sightings, and information during his 1976 presidential campaign, in truth he failed to keep those promises. Carter claimed it was for the safety of national defense but some still speculate on the reasons behind his lack of disclosure. There is a chance that this mystery is, in fact, solved but if it is, the government refuses to say.

Mystery of the 1947 UFO Invasion



June 21, 1947, Harold Dahl and three other people were in their boat off Maury Island (now called Vashon Island) when they reported seeing six flying saucers dumping hot, black, lava-like rocks on the water and land. Dahl told the supervisor of his private beach home security company, Fred Crisman. The next day, a Man In Black came to visit Dahl and told him to keep quiet if he loved his family.

Two days later, Kenneth Arnold, a pilot who ran a fire equipment business, took off from Chehalis, and reported spotting nine UFOs tooling along at more than 1,000 mph between Mount Rainier and Mount Adams. On July 5 of that year, the crew of a United Airlines DC-3 also reported nine flying discs near Mount Rainier. The media picked up the stories, which resulted in even more sightings of things that appeared to have come from outer space.

Arnold and Crisman started meeting with reporter Paul Lantz of the Tacoma Times and two men from Army Intelligence, Capt. William Davidson and 1st Lt. Frank Brown.

Crisman is reported to have given the two military men a box of the mysterious debris allegedly dropped by UFOs around midnight July 31. The two pilots took off from McChord Field shortly after 2 a.m., en route to a base in California. At 2:35 am, several people witnessed the B-25 bomber on fire, circling over Kelso and Longview, and police raced to the crash in Rose Valley.

An article in The Daily News was that afternoon didn't mention the UFO theory but at the Tacoma Times, Lantz was told by anonymous callers that the B-25 was carrying flying disc fragments and that McChord Field officials had stated it was shot down or sabotaged. A caller had inside information, including the names of the pilots who had died before the information was released to the press.

Lantz's story was headlined "WRECKED BOMBER CARRIED DISC SECRETS." Other newspapers picked up the story line. The next issue of the weekly Kelsonian-Tribune carried the headline "Flying Disk Investigators Die in Army Bomber Wreck."

Lantz died six months later at age 29 of streptococcal meningitis but reportedly only after two more Men In Black had come to urge him to abandon the flying disc story.


Description (In Witness's Own Words): I was driving to the shore for vacation when I saw a silver object in the sky. I stared for a few seconds then it flew into the clouds.

Investigator's Notes: The witness did not leave any contact information so no follow-up can be rendered. He reported that the object entered a cloud. Perhaps the cloud was associated with the object and not a weather phenomenon? Objects disappearing into clouds have been observed in other sightings

With not remembering how these 3 being have left, he woke up in the morning to find his bedroom in disarray. He had asked his wife if something had happened in the bedroom because it was so messy and she didn't know what Phil was talking about. He assumed it was all a nightmare and went on with his day. At that time, Phil was working in sales and he remembers holding the telephone to his left ear and he felt a tingling and a ring. A very sharp ring. Then he would take the phone away from his ear and he would not feel anything. He decides to hold the phone to his right ear and everything was alright. A few days later, he remembers talking to someone in Eastern Pennsylvania and they asked him if he had heard about the UFO sighting and Phil had not. It was documented that night and he didn't know what to make out of it. He remembers that evening, he had to take one of the kids mattresses from one room and put into another room and he lifted the mattress and he got this electric shock through his fingers as if you rubbed your

foot on the carpet and you then you touch something. As time slowly went on, he started reminiscing of that night. That, this was real and this did happen to him. Well there was a picture, not too far after this incident in 2007. He is standing near the door of his old home and there are 3 circles on the left side of him. He feels there is a connection somewhere.

From that point on, he starts to have some type of a memory, not Deja Vu where you felt like you have been somewhere, but as if he is in two places at once. As if he is living here in the physical realm, but also that he is somewhere else in time. Now, this happens to him every few months since 2007 and still continues to happen to this day. He has this experience as if he is living another life and its hard for him to understand it. He does not comprehend what is going on, but actually feels these impressions of a life that he is living simultaneously. This happens in present time as if his soul or spirit is split at a certain time, where it is the present not the past or future, as if he is somewhere else living another life.



Philip is a host on The Horsefly Chronicles Radio with his wife, Julia Siracusa. Monday nights 7pm CST / 8pm EST and also airs on 107.7 FM and 105.3 FM on New Orleans Radio Channels. Through his own radio show, he interviews people who have been abducted, who say something similar and they have had these encounters where they felt they were at two places at one time and that's how he feels to this day.

Phil mentioned that The Greys were grey and he does not believe that they are malevolent. He believes that he has some type of device inside him for the Greys to track him with. He feels this way because in his left ear, it is not a ring, but feels it is a frequency. It is as if someone is turning through the stations of frequency and that is where he feels as if he is somewhere else. Not just through the mind or the conscious mind, but he can feel it. He feels somewhere else that is not in the past and not in the present. Feels as though this is happening simultaneously and is having a hard time comprehending this. Everyone has their own beliefs and opinions, and he does not claim to have all the answers because he would not even believe his own story if he had not experienced it for himself. He knows what had happened to him was real and does not need anyone to tell him that it was real, but feels as though the Greys were not malevolent towards him. He believes that some of us are messenger's for other people to let others know that we are not alone and there is another reason alien beings are out there. That they do exist and that intelligence uses us in some sort of fashion where they track us.

A few years back in a different part of Pennsylvania, there was a time lapse in his home that lasted about an hour and a half that he can not explain. He remembers it happening to him, but can not explain where that hour and a half actually went. With talking to Phil about this incident, I had asked him if he has ever had a regression done to pull the information out of his subconscious mind. He has not. He would like to have someone come out to his home, but has not been able to find anyone. Phil feels a regression would be of importance, but because where he lives, there is not a lot of people who deals in Ufology or MUFON in this area or surrounding area's of Eastern Pennsylvania.

Phil believes the Grey's are real. He says that material objects that are solid to us, do not exist to these beings. It's as if the particles of atoms and molecules and what everything is made up of, doesn't seem to phase them, they can look through it. They can teleport through it. They do not speak words, they speak through a form of telecommunication and that they are able to control us at will, whenever they want to. They can put some kind of deep paralysis on you where they are controlling a part of the brain where we can not move. These are the experiences that Phil is having and that he teaches to other people. That we are not alone.

The one experience that he has had and is kind of grateful for because it's mind-blowing to him when it happens to him is that he is in two places at one time. He talks to his wife, kids and friends all the time about it and they all wish that this would happen to them. It is hard for Phil to explain it, but is adamant that a part of him is somewhere else. What makes him feel this way is that he gets a ring, a frequency heard in his ear and when that happens he can be anywhere at home or work, even on vacation and he stands still and he is somewhere else at the same exact time. It is a feeling to him, an impression or a thought that he is somewhere else that is not Earth. He feels like it is a duplication, a parallel universe or another dimension.

His other experience of the time lapse in his living room where he lost time for hour and a half, well few years ago, since he lives in a haunted house, a paranormal team came into his home. This team out of the 52 teams investigating his home did not believe what Phil was saying about this place. When they came to the home, one of the team members demeanor started to change. As the night went on, this investigator decided to leave one of the female investigators alone in the living room

and Phil felt like that was not a good idea in this house. They were all in the basement and she is trying to contact whatever is in the home and on surveillance for 12 minutes she disappears. Then she reappears back on video. At the same time, the lead investigator was changing and getting very mad and angry. Phil has had a time lapse for an hour and a half in this same area of the house. The 12 minute disappearance was caught on video. There has to be some sort of vortex, portal or parallel universe for these time lapses.

Phil may not exactly know what is going on, but knows that his experiences are real and is really happening to him. It's hard for him to wrap his mind around feeling like he is somewhere else, having time lapses he can not explain. Feeling some sort of frequency in his left ear as a tracking device placed in him at his home of residence. Having evidence that UFOs were sighted the same night of his experience. The feelings of being electrocuted and shocked from trying to pick up his children's mattress and always photographing 3 perfect round circles in formation on his left side in photographs. He believes that they are with him all the time, monitoring and tracking his every move.

About 3 in 5 people believe in extraterrestrial life, and of that share, almost 4 in 5 said the government has concealed information about unidentified flying objects. With experiences like Phil's, we can bring more truth out to the world that extraterrestrial life does exist and they are visiting earth as well as living here among us.

Beyond the Gravestones Paranormal Magazine has come together to gather up a way to give Philip Siracusa a regression on this particular incident with the Greys. I strongly believe that it would help immensely in many aspects of this incident and to be given the answers on what really happened that night of July 7, 2007. Rendlesham Forest




The incident at Rendlesham Forest may be one of the best pieces of eyewitness evidence for alien existence. We may never know the full story of what happened between December 26 and 27, 1980. It is one of the few officially documented UFO sightings where witnesses claim to have seen a craft land.

James Penniston was sent as part of a team to investigate an aircraft crash after strange lights were observed emitting from the trees. What they saw was a strange triangular aircraft, unlike any they had seen before. Officer Jim Penniston's witness account describes a craft made from smooth, opaque, black glass and was covered in hieroglyphic-like characters. When they approached, their radios malfunctioned and the air seemed to pop and fizzle with electricity. After they inspected the aircraft, the lights emitting from the side started to burn brighter, and the aircraft soundlessly rose from the ground. The soldiers chased it into a field, where it abruptly shot upward, shining brilliant lights down on them. At that moment the witnesses lost consciousness. When they came to, they were back in the forest.

The morning after the incident witnessed by Burroughs and Penniston, indentations on the forest floor were spotted, as well as damage to the trees in the area where the lights had been seen. Radiation levels recorded at the site of the indentations were also reported to be unusually high. Burroughs, Penniston, and Col. Halt have been the most vocal in saying they believe what they saw was extraterrestrial in origin but they are not the only eyewitnesses. Everyone involved was instructed to never speak of this event, and the following investigation was classified and apart from eye-witness statements no official documents have ever been released to the public.

Billy Meier UFO's



Billy Meier is the source of many controversial photographs of alleged unidentified flying objects, which he presents in support of his claim that he is in contact with extraterrestrial beings. Meier reports regular contacts with extraterrestrials that he calls the Plejaren. Meier claims that the Plejaren look similar in appearance to humans, that the Plejaren homeworld is called Erra, and that it is located in a dimension which is a fraction of a second shifted from our own dimension, about 80 light years beyond the Pleiades, an open star cluster. The Plejaren were given the name Pleiadians by Meier up to 1995.

Meier claimed his first extraterrestrial contacts occurred in 1942 at the age of five with an elderly extraterrestrial man named Sfath. Contacts with Sfath lasted until 1953, shortly before Sfath died. From 1953 to 1964, Meier's contacts continued with an extraterrestrial woman called Asket, who is not a Plejaren. Meier says that after an eleven-year break, contacts resumed again. He has claimed that he has also visited other worlds and galaxies along with another universe with these extraterrestrials.

Many people still claim that Meier faked hundreds of UFO photos he has taken to achieve some form of personal fame and/or monetary gain for himself, despite the positive analyses performed by several competent scientists and photo experts. Most of these allegations are not even backed up by scientific research or they contain false, distorted data. In addition, it is a known fact that numerous photos of Billy's were carefully manipulated in the past to show strings and similar anomalies and were widely distributed in attempts to discredit him. However, the decision as to their authenticity ultimately lies with each and every individual.

The Kecksburg, Pennsylvania UFO Crash



A UFO crash case that is discussed almost as much as the Roswell crash occurred at Kecksburg, Pennsylvania on December 5, 1965. Eyewitness reports coupled with radar confirmed an anomalous object moving through Canada, Michigan, Ohio, and Pennsylvania. The object appeared as a fireball to witnesses, yet it seemed to be under intelligent

control. The Pennsylvania saga began with a report from Frances Kalp, who phoned in her sighting to WHJB radio station in Greensburg at about 6:30 PM.

Kalp stated that she saw an object which appeared to be on fire as it crashed into the woods not far from her house in Westmoreland County. She and her children had gotten to within a half-mile of the crash location. They claimed to see an object which looked like a four-pointed star. John Murphy, who worked at WHJB, immediately called the report in to the Pennsylvania State Police, who in turn called Kalp, and set up a meeting with her in Kecksburg.

Murphy followed his reporter instincts to the site, where he interviewed Kalp and her children for his report. Meanwhile, the State Police were searching the woods for the site of the crash. Murphy was anxiously awaiting a report from the Police regarding their find. Was it a plane? Or something else? When the police emerged from their search, neither Carl Metz nor Paul Shipco, the heads of the search, would reveal any details of their findings.

The only information that the Pennsylvania State Police would release was that they were calling in the U.S. Military to take over. Dissatisfied, but now more intrigued than ever, Murphy phoned the State Police offices in Greensburg, and talked to Captain Dussia. Dussia told him he would have to actually visit the office for an official statement. By the time he reached their offices, the military was already present.


Ironically, after finding something that was beyond the expertise or security clearance of the State Police, and calling in military forces, the official statement denied finding anything.

"The Pennsylvania State Police have made a thorough search of the woods. We are convinced that there is nothing whatsoever in the woods."


Needless to say, Murphy was stunned. He smelled a cover-up. But, of what?

Murphy called in what news he had to his station. Then he happened to overhear one of the State Policeman who had been on the initial search mention a pulsating blue light. So, there was something in the forest after all. The military, along with Officer Metz was taking a second trek into the woods, even though nothing had been found, officially. Initially, Murphy was allowed to go along but arriving at the woods edge, he was turned back.

At least, Murphy became an eyewitness to the area being sealed off. No one was allowed anywhere

near the scene. In a very short period of time, the news of the crash had reached television and newspaper media. The area would soon fill up with people who wanted to get word of what exactly crashed in the Kecksburg woods, and why the military was keeping it to themselves.

It soon became apparent that the State Police were not the first individuals to go into the woods. According to UFO researcher Stan Gordon, several inquisitive locals had been there before police or military had arrived. They described to Gordon a bronze-colored object, about 9-12 feet in length with a gold band surrounding its bottom part. It appeared acorn shaped.

The U.S. Air Force, after finishing their investigation, issued their official version of what happened. They stated that a meteorite had been responsible for the fiery crash into the woods of Kecksburg. For the most part, this simple explanation seemed to satisfy the general public. Was this the end of the Kecksburg mystery? It might have been had it not been for the Unsolved Mysteries television show. The airing of the Kecksburg segment in the 1990s began an entirely new investigation into the matter.

It seems that John Murphy, who was so eager to find the truth behind the Kecksburg crash, gave up his battle rather easily. Maybe not. After his death, his widow told a shocking story. She said that her husband was one of the first to the object, and had taken a photograph of the object. This photograph was confiscated by the military, and he was instructed to not reveal any details of what he had seen that day. Should he go against the warning, he would suffer severe consequences.

Interestingly, Project Blue Book's report on the Kecksburg case does confirm that there was a photograph of the object in the woods but they did not include it in their report or discuss its source. There are still many unanswered questions to be answered about what crashed into the woods near Kecksburg, Pennsylvania in 1965.

Some years later, amid pressure to release the truth about the Kecksburg incident, NASA admitted that they'd examined debris from the site and found that it had been a Russian satellite. When ordered by a judge to produce the documentation of their findings, NASA seemed to have misplaced them.

The only Soviet candidate that remotely fit was Kosmos 96, an acorn-shaped satellite which wasn't nearly as big as the Kecksburg object. Even NASA's chief scientist for orbital debris, Nicholas L. Johnson, stated that Kosmos had nothing to do with the fireball sightings or the crash, which may still turn out to be two separate events. US Space Command also reported that Kosmos crashed in Canada 13 hours before the sightings started.

In 2003, scientists discovered topless trees leading toward the spot where the object was reportedly found.

Alien Abduction



A huge number of people all over the world have claimed they have been abducted by extraterrestrials and in some cases more than once.

The general public may scorn and ridicule but many in the psychiatric community believe the phenomena is real, and occurs frequently.

You might recall talking to these beings and possibly see strange letters or shapes. You might have certain feelings and emotions attached to this dream, and recall being back in your car or bed. You might start to experience paranoia, anxiety and feelings of dread and of being watched.


Chances are you might find that you have experienced this before, and that you are re-calling an event or events that have occurred but are perhaps too harrowing or traumatic for you to deal with on a conscious level.

Perhaps you have been, like many people across the planet, abducted by extraterrestrial beings.

Since the beginning of recorded history there have been accounts of sudden mysterious disappearances of men and women, and folklore often attributes these occurrences to supernatural beings, such as fairies or spirits, taking humans for unspecified reasons, with no trace of these missing humans being seen of or heard from again.

It has only been since the 1960s that many have claimed that it is actually extraterrestrial beings and not mythical/supernatural creatures that are behind people vanishing. Many in the general population may laugh and jest about the topic of little green men probing people but the fact is Alien Abduction is a phenomena, and has been happening for many centuries.

Many ordinary human beings, living ordinary lives as diverse as happy housewives to high-powered businessmen, have reported encounters where they have been taken unwillingly from the confines of the safety of their homes or vehicles to other places, perhaps on spaceships, where they describe, in most cases, being examined, probed and in some cases implanted or impregnated by a group of



aliens many call Greys, as they are small large headed beings who are grey in skin tone. These beings are said to appear and paralyze their victims, have telepathic communication with their captives and perform medical operations or procedures on their patients which may be of a intrusive and violating nature.

Abductees, as they have collectively come to be known, almost always are returned and may or may not remember fully the experience, and are left with feelings of loss, pain and trauma, akin to perhaps rape victims.

Since the early 1960s people have reported abduction encounters that are very similar in tone and description, and the phenomena has become an intriguing aspect of UFOlogy, with any abduction experience being classed as an encounter of the fourth kind.

The topic became more well-known in the mainstream public in 1957 when a Brazilian farmer claimed he was taken from his farm and had sex with an alien on board a spacecraft, however the first massively reported case in English speaking countries was, the famous Hill abduction case, where an inter-racial married couple claimed to have been taken from their car while returning from Canada.

Another well-known case is of Travis Walton, a logger who in 1975 claimed he was taken by small entities aboard a spacecraft. His story, however, has been blown up and exaggerated in a film adaptation to possibly fit with popular abduction lore, his encounter was much more mundane and less horrific.

Many in the psychiatric community have become over the decades convinced the phenomena is real, and some advocate the use of hypnosis as a way to recall the memories of the full events. However, there are those that still say that abductees are simply fantasy-prone, delusional, lying or suffering from an undetermined mental illness. Many believe the use of hypnosis can be suggestive and mis-leading, and suggest perhaps what really occurs is a state of sleep paralysis, a condition that occurs possibly due to disrupted REM sleep where the entire body experiences a weakness of the muscles. Terrifying visions and hallucinations are known to occur during this event.

Many abductees come to believe that they have been abducted several times, perhaps starting at childhood, and statistics show that females are more commonly taken. Some of these women have claimed they have been mothers to hybrids, the offspring resulting from insemination by these entities that are said to be half human-half alien. Many have claimed to have had eggs and sperm taken forcefully from them, and many claim to have been implanted with small metallic chips to be located and catalogued.

Although Greys are usually the creatures said to be behind abductions, Reptilians and Nordics are other classes of extraterrestrials said to also occasionally abduct humans and animals. Conspiracy theorists claim the major world governments are in league with several alien races, and have agreements with them regarding abductions and tests.

Many mental health professionals, scientists and paranormal researchers remain divided on this phenomena, and it is alleged that a lot more people are possibly abducted than is being reported and acknowledged.

1973 UFO Encounter in New Hampshire



It was around 2:45 A.M. on a Friday morning in 1973 that Lyndia Morel found herself fighting sleep behind the wheel of her car. As she drove down New Hampshire's interstate, a bright light caught her attention. The further she drove, the brighter and closer the object in the sky became. Soon, her vehicle began increasing speed and pulling to the side of the road on its own. As if under the guidance of the looming bright object that was now almost above her car. It was at that moment that Lyndia was able to see that the light was some form of craft, being piloted by a small grey humanoid creature. It was unlike anything she had ever seen before or since.

Lyndia, a masseuse had left work earlier that morning and met with a friend for a quick cup of coffee before going home near the town of Goffstown. While traveling down highway 114 she first noticed the bright light off into the distance. It was flashing a yellow hue before changing colors to green, blue, and red. Lyndia didn't think much of this and continued down the desolate stretch of road to her destination.

As she approached a quiet and dark intersection, she lit a cigarette to shake the sleep off and that's when she noticed the bright object had vanished. It was only after she accelerated through the intersection that it reappeared in her field of vision.

By now her attention was fully on this object that seemed to be following her through her journey. The object began to disappear again, only to reappear brighter and bigger than before. Lyndia's sleep was replaced by a growing worry that this object was anything but a star.

It was near the town limits of Goffstown that the strange object finally caught up to her. There, in full horror, Lyndia was able to make out the details of the bright object, which was obvious to her now that it was a form of craft she had never seen before. She would later describe it as a gold and orange glowing globe that appeared to be covered by hexagon shapes. Almost looking like a honeycomb. She then was able to see an opening in the craft. An oval shaped window with what appeared to be some form of humanoid at the controls.

Suddenly bright blue, green, and red flashes of light engulfed her car and illuminated the dark road around her. In the chaos, a loud high-pitch whirling sound became increasingly louder. She was unable to take her hands off the steering wheel, as if the craft had somehow taken control of her and her vehicle. The out of control car raced past the Westlawn Cemetery, as the craft got closer and lower to the road.




The front door finally opened and Mr. and Mrs. Beaudoin stood in their nightgowns, puzzled as to what was going on. There, cowering on their front porch was Lyndia. She was covering her ears and saying that a flying saucer was after her. Both Mr. and Mrs. Beaudoin looked around the property and up at the night sky. It was quiet and still as it had been to them the entire night.

Finally a few minutes later Mrs. Beaudoin called the police to report the erratic woman's claims. Minutes later Goffstown's Officer Daniel Jubinville finally arrived at the residence. He noticed Lyndia's abandoned car in the driveway. The headlights were still on and the engine running. After listening to Lyndia's story and being satisfied that she was not under the influence of drugs or alcohol, he wrote the incident down in his report and headed back to patrolling the roads.

Lyndia Morel never found an explanation for the strange events that unfolded that Friday morning in 1973.



Linda Napolitano – Manhattan



On November 30th 1989, there took place an alleged alien abduction from a 12th story bedroom on the Lower East Side. Linda Napolitano claimed that she was taken into a clam-shaped UFO by curious-looking beings that resembled a type of alien described as The Greys. The abduction was also witnessed by several other people including a United Nations statesman, Javier Perez de Cuellar and his two body guards. They described their experience by saying that they witnessed a woman being floated upwards into a craft accompanied by three small creatures. Other witnesses included an unnamed postman and a telephone operator who was reported as stating that she thought she was watching a Sci-fi movie filming.

The case was brought to light mostly through the work of Budd Hopkins who was a prominent voice in UFO cases throughout his adult life. His work with Linda Napolitano and the Manhattan abduction would take some strange twists and turns with Napolitano even reporting to him that the two bodyguards who witnessed the abduction had kidnapped her later on and pressed her for more information, revealing to her that they were convinced she had something to do with the event. There are some sources that say out-right that the bodyguards turned out to be agents involved with the Central Intelligence Agency (CIA).

Whether or not the case is true and Linda Napolitano really was taken from her New York City apartment, the facts of the case make it one of the most well-documented alien abduction cases in New York's history.

Stefan Michalak



May 20th 1967, a man by the name of Stefan Michalak was exploring the woods near Falcon Lake, Manitoba, Canada when he saw two cigar-shaped UFOs land close by. One of the doors opened on the craft and that's when Stefan heard voices and he attempted to communicate with them. With no success, he approached the craft but couldn't make out anything inside except for what he described to be a maze of lights. Suddenly, the aircraft's door closed, and the object began to rise. It then expelled some sort of hot air at Michalak through a grid-like vent that caused his shirt to erupt in flames. He was taken to the hospital, where the doctors were completely puzzled by the burn marks on his chest. After this bizarre accident, Michalak got very sick, suffering from symptoms typical of radiation but the nature of the burns has remained a mystery.

Q) How did you become involved with the ERC-Extraterrestrial Research Center?

A) As a UFO/UAP certified field investigator, that I received my training from when I was with MUFON (Mutual UFO Network). I was at the time working with the Delaware Chapter with MUFON but myself and a team of people had left the organization due to some things we weren't with at the time. A few members and myself decided we wanted to form another organization but several of those people decided to go into a different direction. I decided to see things through and with my co-founder, Lou Dimieri whose my Director of Research. We decided to move forward, and so I set forward to put together ERC- Extraterrestrial Research Center. I've always enjoyed investigating cases and looking for answers.



Q) Working with teammates Joshua Chaires and Melissa Sloan Ferrazzano with Phantom Detectives, have you found through all your research that there may be a connection between extraterrestrial beings and ghosts?

A) Well, I do believe in both extraterrestrial beings, and spirits from people that passed away but I also believe that both sides of the paranormal can cross paths. I investigated a case once where both video evidence that was presented to me had captured both a spirit at a graveyard and also a portal that morphed into different shapes was possibly extraterrestrial in nature.

Q) Have you ever witnessed any species of extraterrestrial beings and have you ever eard of the tall whites with bright lights through their eyes?

A) I haven't personally seen any alien species myself but that doesn't mean they don't exist. Many people that have claimed to be abductees that have undergone hypnosis have described several different types of species and many of these cases have presented may similarities.

I have heard of the Tall White species, and some say they are 6 to 7 ft tall but others have also claimed they can be as tall as 10 ft. They are described as having chalky white skin and the suits they wear can emit bright lights that hurt the eyes.

Q) What are your thoughts about life on mars? And do you believe Mars will be our next Earth?

A) There's some evidence to suggest that there was once water on planet mars which could also suggest some possible life forms as well. One of the things that need to be looked into further are the medical implications, and strain on the human body. Also consider that Mars is around 140 million miles away and the trip getting there takes about 6 to 8 months. Food and fuel getting Mars can be extremely expensive and you need plenty of both for the trip down there and back. NASA is working on a faster propulsion system that would get people quicker to the Red planet. I'm not sure about Mars ever replacing the planet we live on but I think we are a long time out before people would start living on the planet. I think only a small team of people would be going there to test things out first before large amounts of people start arriving to the planet.

Q) How far away do these extraterrestrial beings come from in space? And do you believe that many species are living here on Earth?

A) With all the billions of planets that haven't even been discovered yet it could be that some of these extraterrestrial beings are millions of light years away. I believe that there are alien hybrids being bred among us that have both alien and human DNA and look like us.



Q) What are your thoughts on possible extraterrestrial UFO invasion here on Earth?

A) I think it's definitely a possibility but I think the abbreviation UFO is often misused and the term UAP- Unidentified Aerial Phenomena is an abbreviation that is slowly replacing the older abbreviation. Currently there is an organization such as the AEDC- Alliance Of Extraterrestrial Diplomatic Contact that involves a large group of people that are working on finding a host country that will house an embassy strictly for alien races. There are some that feel these beings would come to our planet in peace while others feel that they may not have good intentions for us. I believe that some races would come to this planet with peace in mind but I don't feel that all alien species would necessarily come to our planet in peace.

Q) Can you tell us through your research, what happens to individuals who are abducted into a UFO Spacecraft and how they may be treated by the extraterrestrials?

A) As a trained investigator most of the cases I've been involved with aren't abduction cases. I've interviewed a few abductees also known as experiencers. There are many things that have to be looked at to establish credibility, and remember anyone can tell you anything and that doesn't mean everything someone tells you is true. This is why as investigators we need to not only thoroughly ask questions but also look at and analyze the evidence presented to us. There have been many abductees that have undergone hypnosis and many of these people have reported the same type of experiences. Some of these experiences have been reported as being very painful and feelings of being very scared. Some people have experienced things such as skin marking such as Red dots on the skin in different formations, skin that appeared scooped out, bruises, discolorations and even implanted devices that have been found in the body that couldn't be explained.

Q) Do you think that the buzzing in people's ears after an extraterrestrial encounter is something that they have planted for them to track us? And why do you think they put implants in us?

A) Not everyone that has been abducted experience the same things. I'm not really sure about the buzzing as that's not familiar to me but I do believe that the implanted devices are used as some type of tracking devices. Implanted devices have been found in different shapes and sizes and many have been found at the base of the thumb where it meets the fleshy part of the skin and some devices have been found behind the neck as well as other parts of the body. Many of these devices have been found to have a membrane over them that can be difficult to cut through.

Q) Do you believe that the white owl is the extraterrestrial beings disguised to watch us?

A) No that isn't something I ever heard of or believe.

Wyoming, 1960 UFO



A farmer in Wyoming was out tending his field when he saw a UFO flying over his field. The UFO came back day after day and he knew nobody would believe him. So, one day he brought along his camera and managed to capture this UFO picture. He never noticed any cows missing during the day but was convinced that something funny was going on with them at night. It certainly wouldn't have been the first report of UFOs having an interest in cows.

Area 51



Area 51 is a military base, and a remote detachment of Edwards Air Force Base. It is located in the southern portion of Nevada in the western United States, 83 miles (133 km) north-northwest of downtown Las Vegas. Situated at its center, on the southern shore of Groom Lake, is a large military airfield. The base's primary purpose is to support development and testing of experimental aircraft and weapons systems.

The base lies within the United States Air Force's vast Nevada Test and Training Range (NTTR), formerly called the Nellis Air Force Range (NAFR). Although the facilities at the range are managed by the 99th Air Base Wing at Nellis Air Force Base, the Groom facility appears to be run as an adjunct of the Air Force Flight Test Center (AFFTC) at Edwards Air Force Base in the Mojave Desert, around 186 miles (300 km) southwest of Groom, and as such the base is known as Air Force Flight Test Center (Detachment 3).

Though the name Area 51 is used in official CIA documentation, other names used for the facility include Dreamland, Paradise Ranch, Home Base, Watertown Strip, Groom Lake, and most recently Homey Airport. The area is part of the Nellis Military Operations Area, and the restricted airspace around the field is referred to as (R-4808N), known by the military pilots in the area as The Box or The Container.

The facility is not a conventional airbase, as front line operational units are not normally deployed there. It instead appears to be used for highly classified military/defense Special Access Programs (SAP), which are unacknowledged publicly by the government, military personnel, and defense contractors. Its mission may be to support the development, testing, and training phases for new aircraft weapons systems or research projects. Once these projects have been approved by the United States Air Force or other agencies such as the CIA, and are ready to be announced to the public, operations of the aircraft are then moved to a normal air force base. The intense secrecy surrounding the base, the very existence of which the U.S. government did not even acknowledge until July 14, 2003 has made it the frequent subject of conspiracy theories and a central component to unidentified flying object (UFO) folklore.

Its secretive nature and undoubted connection to classified aircraft research, together with reports of unusual phenomena, have led Area 51 to become a focus of modern UFO and conspiracy theories. Some of the activities mentioned in such theories at Area 51 include:

The storage, examination, and reverse engineering of crashed alien spacecraft (including material supposedly recovered at Roswell), the study of their occupants (living and dead), and the manufacture of aircraft based on alien technology.

Meetings or joint undertakings with extraterrestrials.

The development of exotic energy weapons for the Strategic Defense Initiative (SDI) or other weapons programs.

The development of means of weather control.

The development of time travel and teleportation technology.

The development of unusual and exotic propulsion systems related to the Aurora Program.

Activities related to a supposed shadowy one world government or the Majestic 12 organization.

Many of the hypotheses concern underground facilities at Groom or at Papoose Lake (AKA "S-4 location"), 8.5 miles (13.7 km) south, and include claims of a transcontinental underground railroad system, a disappearing airstrip (nicknamed the Cheshire Airstrip, after Lewis Carroll's Cheshire cat) which briefly appears when water is sprayed onto its camouflaged asphalt, and engineering based on alien technology. Publicly available satellite imagery, however, reveals clearly visible landing strips at Groom Dry Lake, but not at Papoose Lake.

Veterans of experimental projects such as OXCART and NERVA at Area 51 agree that their work (including 2,850 OXCART test flights alone) inadvertently prompted many of the UFO sightings and other rumors.

The shape of OXCART was unprecedented, with its wide, disk-like fuselage designed to carry vast quantities of fuel. Commercial pilots cruising over Nevada at dusk would look up and see the bottom of OXCART whiz by at 2,000-plus mph. The aircraft's titanium body, moving as fast as a bullet, would reflect the sun's rays in a way that could make anyone think, UFO.

They believe that the rumors helped maintain secrecy over Area 51's actual operations. While the veterans deny the existence of a vast underground railroad system, many of Area 51's operations did occur underground.

Several people have claimed knowledge of events supporting Area 51 conspiracy theories. These have included Bob Lazar, who claimed in 1989 that he had worked at Area 51's S-4 (a facility at Papoose Lake), where he was contracted to work with alien spacecraft that the U.S. government had in its possession. Similarly, the 1996 documentary Dreamland directed by Bruce Burgess included an interview with a 71 year old mechanical engineer who claimed to be a former employee at Area 51 during the 1950s. His claims included that he had worked on a flying disc simulator which had been based on a disc originating from a crashed extraterrestrial craft and was used to train US Pilots. He also claimed to have worked with an extraterrestrial being named J-Rod and described as a telepathic translator.

In 2004, Dan Burisch (pseudonym of Dan Crain) claimed to have worked on cloning alien viruses at Area 51, also alongside the alien named J-Rod. Burisch's scholarly credentials are the subject of much debate, as he was apparently working as a Las Vegas parole officer in 1989 while also earning a PhD at SUNY.

The Philip Spencer Experience



In the early morning of Tuesday, December 1 1987, Philip Spencer an ex-big city policeman, recently moved to the Ilkley area of West Yorkshire in deference to his wife's wishes, set out southward across Ilkley Moor equipped with a compass for navigation and a camera. He was apparently hoping to catch on film some of the strange anomalies that the off time spooky moor is noted for while on the way to visit his father-in-law in East Morton.

Within minutes he was surrounded by a cold, damp Yorkshire fog, the mist itself almost a living thing and it was through a parting of the mist that he allegedly first glimpsed the alien, a diminutive being waving at him as though telling him to leave. At this time Spencer remembering his camera took a shot, then yelled, the creature as though startled moving out of site. A few moments later it was the policeman's turn to be startled as a strange craft looking like two saucers stuck top to bottom with a domed top lifted off from behind an outcrop and with a loud humming sound disappeared skyward.

Unsure of what had just happened and perhaps doubting his sanity, Spencer decided to call off the visit to his in-laws and head instead for the nearby village of Menston a thirty minute walk. On the way he noticed the needle on his compass now pointed south instead of north and upon arrival that the church clock indicated the time to be 10:00 a.m., not the 8:15 a.m. which by his reckoning it should have been.

Thoroughly confused and needing confirmation of what he had just seen he decided to head to Keighley and get the film in his camera developed. A short time later he was looking at what appeared to be an image of a four foot creature with long arms and bluish green skin. An analysis of the photograph by Kodak laboratories in Hemel Hempstead, revealed that as far as they could tell it had not been doctored in any way. The photo was then sent to the United States and computer enhanced, the results inconclusive.

As for Spencer, he purportedly began to have strange dreams. Having already contacted Peter Hough, a UFO investigator, he now agreed to undergo regressive hypnosis, the gist of which was that he had been abducted, given some sort of examination, a tour of the spacecraft and a quick trip into orbit after which he viewed some videos. The first concerning a future apocalypse, the second he was forbidden to talk about, before being returned to the moor unharmed. The snapshot apparently taking place after the abduction, the creature waving goodbye.

Men in Black / The Grinning Man



In October, 1996 two boys in New Jersey were walking home at night when they encountered and were subsequently pursued by a strange, tall, grinning man. He was claimed to be over six feet tall and dressed in a shimmering green suit. Reportedly, the man had no hair, eyes or ears. His eyes were dark and beady and his only expression was his eerie grin. The Grinning Man phenomenon has been reported several times.

Again, in November of the same year, Woodrow Derenger was overtaken by a strange, speedy vehicle whilst driving home in his truck one night. He later encountered the vehicle further down the road, where a man with a matching description to the one sighted in New Jersey, exited and began to telepathically communicate with Derenger about UFO sightings in the area.



Did Kennedy's Interest in UFOs Get Him Killed?



JFK Conspiracy at 50

Last year, the month of November marked the 50th anniversary of the JFK assassination, as well as the 50th birthday of one of the greatest conspiracy theories of all time. On November 22nd 1963, a photogenic, charismatic, beloved president had half of his head blown off in broad daylight in front of a roaring crowd in Dallas. Almost from the get-go, conspiracy theorists critiqued the official version of events issued by the Warren Commission, saying it simply wouldn't have been possible for a single man, Lee Harvey Oswald to have made the hit from the Book Depository overlooking the Dealey Plaza.

The conspiracy theories proffered over the subsequent 50 years include a veritable who's who of global power players: the CIA, the mafia, anti-Castro Cuban exile groups, agents of the military industrial complex, sitting Vice President Lyndon B. Johnson, Cuban President Fidel Castro, FBI director J. Edgar Hoover, the Federal Reserve, the KGB and, of course, Zionists. In fact, at this point it's probably better to ask who didn't kill Kennedy. The motives are as equally diverse: escalation of the Vietnam War, defense contractor profits, appeasement policies toward Cuba and the Soviet Union, political animus, restrictions on the Federal Reserve, the Cuban Missile Crisis, etc. Conspiracy theorists often

pair these groups and motives in clusters of two and three, as if ordering off a Chinese menu.

A more recent theory posits a new motive for Kennedy's killing, his knowledge of UFOs. Recent documents turned over to the public under the Freedom of Information Act reveal that Kennedy had requested to see all CIA files regarding UFOs. In his letter to the Director of the CIA, dated November 12th, 1963 (ten days before his assassination), Kennedy states that it is essential that all documents related to UFOs be turned over.

A second letter, sent to NASA on the same day, requested that the organization assume responsibility for working with the Soviet Union on matters related to outer space. It seems Kennedy wanted to prove to the USSR that recent unidentified flying objects were not provocation on the part of the U.S.

This wasn't the first time Kennedy had requested disclosure of highly classified information. In 1961, he gave a now-famous speech in which he called for an end to secret societies and government cover-ups. More specifically, Kennedy said:

"We are opposed around the world by a monolithic and ruthless conspiracy that relies on covert means for expanding its sphere of influence on infiltration instead of invasion, on subversion instead of elections, on intimidation instead of free choice, on guerrillas by night instead of armies by day. It is a system which has conscripted vast human and material resources into the building of a tightly knit, highly efficient machine that combines military, diplomatic, intelligence, economic, scientific and political operations.

Its preparations are concealed, not published. Its mistakes are buried not headlined. Its dissenters are silenced, not praised. No expenditure is questioned, no rumor is printed, no secret is revealed."

There are more than a few government operatives who feel this speech rubbed the wrong people the run wrong way, and when you really think about it, what the hell could have been the point of these provocative statements other than to warn the American press and people about who's really running global affairs? Listen to the whole speech, and ask yourself what Kennedy is really trying to say, what are the specifics he is leaving out here? Why did he make this speech?

NATIONAL SECURITY ACTION MEMORANDUM NO. 271

MEMORANDUM FOR
The Administrator, National Aeronautics and Space Administration

SUBJECT: Cooperation with the USSR on Outer Space Matters

I would like you to assume personally the initiative and central responsibility within the Government for the development of a program of substantive cooperation with the Soviet Union in the field of outer space, including the development of specific technical proposals. I assume that you will work closely with the Department of State and other agencies as appropriate.

These proposals should be developed with a view to their possible discussion with the Soviet Union as a direct outcome of my September 20 proposal for broader cooperation between the United States and the USSR in outer space, including cooperation in lunar landing programs. All proposals or suggestions originating within the Government relating to this general subject will be referred to you for your consideration and evaluation.

SUBJECT: Classification review of all UFO intelligence files affecting National Security

An I had discussed with you previously, I have initiated [redacted] and have instructed James Webb to develop a program with the Soviet Union in joint space and lunar exploration. It would be very helpful if you would have the high threat cases reviewed with the purpose of identification of bona fide as opposed to classified CIA and USAF sources. It is important that we make a clear distinction between the known and unknown in the event the Soviets try to mistake our extended cooperation as a cover for intelligence gathering of their defense and space programs.

When this data has been sorted out, I would like you to arrange a program of data sharing with NASA where unknowns are a factor. This will help NASA mission directors in their defensive responsibilities.

I would like an interim report on the data review no later than February 1, 1964.

Bigelow Ranch



The shadow of the Skinwalker has loomed over the property dating back to a curse apparently placed on the lands long ago by a Native American tribe. The shaman cursed this ground with this demonic being that can take the form of a wolf, a coyote or crow or human. Accounts of the unknown are believed to date back well into the 1800s.

Terry Sherman got so spooked by the happenings on his new cattle ranch that 18 months after moving his family of four to the property now known by many as Skinwalker Ranch in northeastern Utah. He sold the 512-acre to Las Vegas real estate magnate and UFO enthusiast Robert Bigelow who bought the property for \$200,000. Under the name the National Institute for Discovery Science, Bigelow set up round-the-clock surveillance of the ranch, hoping to get to the bottom of the paranormal claims.

Unexplained cattle mutilations, and cattle that just disappeared. Ten of the Sherman's cows reportedly vanished. UFOs the size of football fields and in 1980, a rancher claimed to have seen a 40-foot silver sphere on the ground of what later became the Sherman ranch. Terry Sherman claimed to have actually seen aliens come out of one UFO and claimed it was a human type, seven feet tall and in a black uniform.

Interdimensional portals that were seen to open in mid-air. The Sherman's said they saw lights emerging from these doorways. Floating balls of light, one of which might have toasted the family dogs. The Sherman's three dogs vanished after chasing a ball of light. A circular burn mark was found on the ground near where the dogs were last seen. Gwen Sherman was supposedly chased by several red balls of light while driving home one night.


With 200 years of strange occurrences happening on and around the area, such as animal mutilations, sightings of strange creatures, reports of UFOs and other unexplained oddities, the site has been at the center of speculation for a very long time. Bigelow, who purchased the ranch in 1996, had spent many years with his own team of researchers looking into Skinwalker and trying to find causes for the things that have been reported there, but those findings were never made public.

Zingmund Adamski



On June 5th 1980, a man named Zingmund Adamski disappeared while running errands. It wasn't until five days later, that his dead body was found 20 miles away in a pile of coal. The man's watch and wallet were missing but his clothes had no damage to them. He was discovered at 3:00 pm but he was suspected to have died anywhere between 11:00 am and 1:00 pm. This is odd because the workers at the coal plant did not see him when the area was last used at 11:00 am. The autopsy revealed that Adamski died of a heart attack and had burns on his neck and an unidentifiable ointment had been applied to the burns. What is odd about this case is that Adamski had stubble that looked like he hasn't shaved in a day. The man was missing for five days, and yet didn't show signs of having a unkempt beard consistent with that amount of time. Many speculate that he was taken by aliens and tortured. It is believed that when he died the aliens left him at a random location.

The Hessdalen Lights



The Hessdalen Lights are a spectacular but unexplained light show that can be seen various times throughout the year in the skies over Norway. The lights were most active from 1981 through 1984, when people traveled from all over the world to camp out and see the lights which were said to be visible 15-20 times per week. These days, the sightings are down to about 15-20 times a year.

A scientific explanation for these lights remains unproven, leading many to hypothesize that they are caused by alien spacecraft. Other sightings including headlights, mirages, astronomical bodies and aircraft have been noted.

However, as of May 2014, some scientists think they might have uncovered the mystery. The hypothesis is that the metallic rock inside the mountains, combined with the heavy amounts of sulfur in the river, have created a battery. When ionized gas is created from the fumes, the lights become visible. This theory is still not proven, though, and the mystery continues.

Cattle Mutilations



Cattle mutilation is the apparently mysterious killing and surgically precise mutilation of cattle and other animals.

With a number of theories, earthly and un-earthly, having been put forward to answer this phenomenon, why are cattle mutilations still shrouded in mystery?

In September, 1967 a horse by the name of Lady brought world-wide attention to a phenomenon that had already been recorded for decades, and considered by many to be, although strange, natural. Mostly documented to have occurred in the United Kingdom, farms and ranches in the American states of Pennsylvania and Kansas in the 1960s were also the sites of strange deaths happening to livestock, mainly cows and bulls, with the mutilated corpses left to be found. This has puzzled many locals, law enforcement officials and scientists up to this day.

Bizarre mutilations of cattle have since been reported throughout Northern America and Canada, and other parts of the planet, including Australia.

Lady was a three year old mare who one night did not return to drink on a ranch near Alamosa, Colorado. Two days later the ranch owner and her son found Lady's body. Her head and neck had been skinned and de-fleshed, and a medicinal odour was smelt. It was noted that cuts to the corpse appeared to be precise and surgical, and no blood was found at the scene.

The U.S. Forest Service was contacted and a ranger appeared and investigated. Almost a month later the media got wind of the story and Lady (re-named Snippy) and her bizarre death were splashed all over newspapers across the United States, and soon similar cases began surfacing and being reported all over the continent.

Cattle mutilations are bizarre and puzzling for a number of reasons. Firstly, most attacks are quick, and usually take place at night. The bodies are found with surgically precise cuts, clean wounds with no blood in or around those wounds. The body is exsanguinated (drained of all of its blood), and no blood is left at the scene. Major organs are taken, as well as sex organs, and in some cases anal coring is exhibited. Eyes, tongues, lips, ears and sometimes tails and legs are missing. Flesh is cut to the bone in an immaculate manner, and bodies are often found dumped in an area with no tracks, human or otherwise, found leading to or moving away from the corpse.

Sometimes bodies or body parts are found draped over fences or up in trees, and sometimes appear to have been dropped from a height. And, even more bizarrely, scenes are sometimes found with scorch marks in grass similar to crop circles, and some, like the case of Lady have been near areas where radio-activity levels are found.

This has lead, of course, to many believing that UFOs and their inhabitants are behind the deaths, and are collecting specimens for whatever reason or motive. There have been reports of strange lights being seen in regions before or after these murders but the jury is still out in regards to extraterrestrial organ harvesting and blood-letting.

Many scientists attribute the mutilations to naturally occurring deaths of livestock, and the end result is usually the behaviour of predators, such as vultures, crows, coyotes, wolves and foxes. It has been proven in experiments that scavengers can replicate the precise cuts and wounds found while tearing at the body, and can be responsible for the removal of organs. However, there are some cases that can't be easily explained away to natural acts by other animals, and the extraordinary amount of blood missing would not be carnivorous predators at play.

The F.B.I. and the A.T.F. (Bureau of Alcohol, Tobacco, Firearms and Explosives) both have launched costly investigations into the phenomenon over the years, and have failed to come up with anything concrete in the way of motive or responsible culprits. Many have speculated that it may be Satanic cults moving about, performing ritual sacrifices, and there is evidence to support this, there are a small number of cases that appear to be the result of possible cult behavior.

There are also people who suspect the slaughters are the result of Military experimentation, possibly in regards to cattle diseases and their possible effect on humans. Organs are taken for specimens and bodies are left to be found. It has been alleged that trace amounts of medications usually prescribed to humans have shown up in the bodies of slaughtered animals.

Are cattle being tested on with vaccines, anti-depressants and the evidence of such tests being destroyed?



MUFON Case - Milano, Texas



MUFON Case 41918, 45899: 5:20 a.m., July 14, 2012 Highway 36 near the town of Milano, Texas, and a repeat event six months later near the same location.

At about 5:20 a.m. on July 14, 2012, two men were traveling northwest on Highway 36 and had just passed through the small town of Milano, Texas. The two witnesses saw a pentagon-shaped, black object hovering over the highway ahead of them. At each apex of the pentagon were lights and a more intense light in the middle of the object. The lights at the corners were white and pulsated about once per second. As the witnesses drove under the object they could hear no sound coming from the craft above them. The witnesses saw what they thought were panel lines or vents on the underside of the craft. They estimated that the object was 30 feet above them when they passed under it and the object was about 20-30 feet across. The driver did not want to stop and the two men continued onto their destination.

The primary witness has a BS in chemistry and is working on a master's of science degree. The other witness, who was driving, has some college training.

It is interesting that a very similar case occurred on this same stretch of highway but six miles farther northwest and six months later, on December 20, 2012. A 35-year-old female and her 16-year-old son were traveling in the same direction on the same road. The witness stated that she and her son first saw the object approach their vehicle from the east. She described the object as about 100 feet across with five sides and flashing lights on each corner. The color of the craft was a dull gray. The craft moved back to the east out of sight. She stated that it came back and hovered directly above their SUV. The witness stated that both she and her son felt threatened by the object. Her anxiety is best described in her own words, "We continued to watch it when suddenly it was RIGHT UP ABOVE our SUV! There are few words that will effectively relay to anyone that wasn't there just how large and utterly surreal looking this thing was. I was in shock and as a mother I became fearful this thing could be a potential threat considering how close it was. So I stepped on the gas to get away from it" At this point the son began to video the object with his cell phone camera. It was too far away at that point to see any detail but it was clear from the voices that the mother was fearful.



Ancient Astronaut Theory



Science once told us that man, as we are today, descended from the ape kingdom, and that our closest living relatives on the evolutionary chain are chimpanzees. Today, however, we know it's a bit more complicated than that, for we know we are not directly descended from existing ape species, but have common ancestors with them.

The biggest mystery asked in evolution is how and why humans have evolved to become so varied. The Missing Link refers to the last common ancestor we have with chimpanzees. So far archaeology is yet to find fossil evidence of an animal that was ancestral to both chimpanzee and homo-sapiens. These ancestors are thought to have existed about 6 to 8 million years ago, and Darwin believed that archaeologists would eventually find this link in fossilized proof, confirming man was descended from apes.

Could there be a possibly larger, and more perceived bizarre and disturbing answer to that enigma?

Maybe we have not discovered this link due to the fact that perhaps, there is more than one ancestor and also, perhaps, it's of an extraterrestrial source!

In 1968 a book emerged into publication called *Chariots of the Gods*, and 55 years later still courts controversy, ridicule and skepticism by the mainstream scientific community and lay-men alike. Its author, Erich Von Däniken, would go on to write several more books and would cement himself as one of the main proponents of the Alien Astronaut Theory, an idea that extraterrestrial beings made contact with early man and helped shape and influence early civilizations.

Von Daniken's claims and works have been labelled pseudo-science, pseudo-history and pseudo-archaeology. The general claims through these books are that Ancient Astronauts visited Earth many millennia ago and helped early man evolve from the apes. It is also put forth that these entities helped humans construct great structures and monuments, such as the Pyramids in Egypt and the statues that are found on Easter Island.

Believers in this ideology would also argue that man was taught by these beings language and writing, agriculture, the arts, technology and social organization, and that we were, perhaps for some time, slaves to these Gods, providing them with food, labor and perhaps even companionship.

What happened to these beings and why they are not around now is also cause for speculation and theory.

Believe it or not but there is evidence to support this theory. Apart from the structures mentioned earlier, that still today have an air of mystery surrounding their creation, there are ancient temples and buildings with pictures depicting early man possibly interacting with strange looking men, depictions of flying machines with men in them, and carvings of lines and objects in sand in southern Peru.

Also many ancient tribes, including the Mayans and Australian Aboriginals, had knowledge of astronomy, mathematics and geometry. A remote African tribe told two French explorers in 1931 that they had acquired their knowledge of astronomy from beings called the Nommo, that resembled fish and were here to watch over mankind.

Many ancient tribes and clans speak of men from the sky who appeared and either guided and instructed them or caused destruction, mayhem and grief. Is it possible that perhaps humankind is descended from an ancestor that was genetically mixed, through laboratory experimentation or sexual breeding, with chimpanzees?

Or perhaps there was more than one ancestor?

Could the fact that we have many cultures, languages and nationalities be because we are the product of breeding done by more than one species of extraterrestrial visitors?

Could that also explain the many religions, myths, folklore and belief systems that exist?



Denise Bishop



In September 1981, Denise Bishop was on her way home. When she got out of the taxi at her home, she noticed odd lights in the sky. She went to the back of her home to investigate and saw a craft hovering. Denise was frightened and frantically tried to open the door. In a bizarre twist, the 23 year old's hand was hit with a green light. The lights disappeared and Denise quickly entered her home. Oddly enough the light that shot her hand made her unable to move it for a few minutes and she developed several burns on the same hand. After her boyfriend and sister were told of the incident, they tried to file a police report with no avail.

The McPherson Tape Mystery



The McPherson Tape is a real movie that has spawned a collection of urban legends. Officially, the film is named **UFO Abduction** and was created by Dean Alioto in 1989 for \$6,500. The movie is one of the first examples of a found footage film and follows the story of a Connecticut family named the Van Heeses who are abducted by extraterrestrials. The movie was made to look like a genuine home video recording that was taken in 1983 and recovered years later.

The film starts out with a birthday party of a 5-year-old child at the Van Heeses house. After a brief period of time, the group experiences a power outage and bright flash of red light is seen. The men go outside to explore the area and find a plane crash over the hill. At the crash site, they witness a collection of extraterrestrials. The aliens scare the group and the men run back to the house in disbelief. Along the way, they use profanity and it becomes clear the movie is not scripted, but rather improvised. In many scenes the actors can be heard yelling over each other. For over an hour, the family attempts to fight off the creatures but the movie ends abruptly with the aliens entering the house and abducting the Van Heeses. At one point in the film the men bring the body of one of the aliens into the house, but it soon disappears.

Throughout the movie, the actors do a great job showing terror and fear. Some have suggested the appearance of the aliens is quite convincing as they have long and slender limbs. However, others have complained about the unrealistic clothing on the creatures. It has become extremely hard to find a copy of **UFO Abduction**. Sections of the movie can be seen on the Internet but the entire footage from start to end is not available. In 1998, a remake of the movie was created by Dean Alioto and aired on UPN. The footage is much less convincing and clearly scripted. Since its release, the footage has been labeled the McPherson Tape because it is said to show the actual abduction of the McPherson family.

Toothbrushes were still on the sink, clothes were still hung up in the wardrobe and family photographs were dotted around the house. Bizarrely, the family were never seen nor heard from again. They left no note, made no phone calls to relatives... they simply disappeared.


This alone was enough to creep the Edmonds out but they knew that the property was perfect for their horses, so they stayed put. However, over recent years, the couple have supposedly been the victims of violent alien abductions and encounters.

John has a plethora of stories and experiences, including seeing his wife levitating high above their bed, to seeing UFOs hovering above his house, and to even slaying several of The Greys with his samurai sword. Tissues from that very sword were sent to a lab and examined by a prominent scientist. The results were pretty shocking.

John claims to have killed 18 of the alien creatures so far and has unloaded clips from his AK-47 at their craft. He claims that their bodies simply disintegrate once they are dead. John's wife, who has always wished to remain anonymous, claims to have been raped by the creatures on several occasions. She is so terrified of this, that she won't even sleep in her bed anymore. So, is this just an elaborate hoax? Or is something strange happening at Stardust Ranch? Another interesting point is that it is situated close to the largest nuclear power plant in America, Palo Verde. Nuclear science has often been tied to aliens, and abductees have often been left with radiation burns. Whether this is real or not, it is certainly creepy.

Aliens Among Us



In the 1940s and 50s reports of flying saucers became an American cultural phenomena. Sightings of strange objects in the sky became the raw materials for Hollywood to present visions of potential threats. Connected to ongoing ideas about life on the Moon, the canals on Mars, and ideas about Martian Civilizations, flying saucers have come to represent the hopes and fears of the modern world.

Are these alleged visitors from other worlds peaceful and benevolent or would they attack and destroy humanity? The destructive power of the Atomic bomb called into question the progressive potential of technology. Fear of the possibilities for destruction in the Cold War era proved fertile ground for terrestrial anxieties to manifest visions of flying saucers and visitors from other worlds who might be hidden among us in plain sight.

If UFOs were visiting our world, where were these extraterrestrials? Could they be hidden among us?

Aside from depictions of UFOs in media, UFOs are also part of American folk culture. Ideas of aliens and flying saucers are a part of the mythology of America. You can find documentation of these kinds of experiences in folk life collections. Scientists and astronomers express varying degrees of enthusiasm for the possibility of intelligent life in the universe. However, scientists generally dismiss the idea that there are aliens visiting Earth.

Our conceptions of alien life are based on a sample of one: Earth's life. That means even our wildest imaginings are likely to be completely off beam. Aliens are almost definitely out there. On average, every star in the Milky Way has a planet orbiting it. Fully one-fifth of those stars have a planet that could be temperate and conducive to life as we imagine it. That's 50 billion potentially habitable planets just in our own galaxy which is one of billions in the universe. That doesn't mean intelligent life is close by. We have been exploring our solar system for a long time, so if it contained intelligent life forms we would probably know about it by now.

Extraterrestrial oceans are an obvious place to search for alien life but getting there and having a look won't be easy. Late 1970s, two different voyages of discovery transformed our ideas about alien life. In 1977, hydrothermal vents were found, belching out smoke in the Galapagos rift at the bottom of the Pacific Ocean. The smoke was actually a superheated fluid rich in hydrogen, methane, hydrogen sulphide and minerals essential to life.

It is just a matter of time before we hear from alien civilizations, in fact, we may already have done so. A new analysis suggests the evolution of human-like intelligence on another planet is more improbable than we like to imagine. It is easy to imagine that intelligent life has evolved on at least one planet around one of the 100 billion or so stars in our galaxy. So easy, in fact, that we tend to assume, given the vastness of the visible universe, that there must be other technological civilizations out there. Yet we haven't heard from them. Why?

A Life Long Alien Abductee in Filey North, Yorkshire England

U Kellett reckons he is a real-life X-Files agent – and says he's got the scars to prove it. He believes he saw his first alien spaceship when he was 10. "I'll never forget it," he says. "It was a huge disc covered with red and white flashing lights. It hovered for a few seconds above the street before shooting off at high speed." Since then the alien expert has had two more close encounters. The 41-year-old says: "I was driving my motorbike back home from work one night.

"When I came to the level crossing the barrier was down so I stopped. Suddenly I was bathed in a hot, bright light. I turned around, expecting to see a car or truck but there was nothing there.

"Then just as quickly as the light appeared, it was gone."

"I looked in the mirror and couldn't believe it: my face and neck were red raw. It was midwinter so there was no logical explanation for it."

He went to the doctor when his skin started to peel and blister – but nothing helped.

"I felt like a leper," he remembers.

"Big patches of my skin started to fall off. And then overnight it cleared up. But I've still got a tiny scar as a reminder. I know it was caused by my close encounter at the crossing."

But if he thought that his skin condition was weird, a year later he was abducted by aliens. Russ continues: "I was out on my motorbike when I noticed a bright ball of light in the sky."

Q) Russ, you have been involved in Alien abductions your entire life, can you tell the readers about your first experience and what it was like to be abducted?

A) I had just started my first job after leaving school at 16 years old. I was lucky for my birthday and Christmas my mum and dad brought me a Suzuki motorbike. After work I had come home and had a shower then had my tea. I had sat down and watched television with my family before going out

on my motorbike. I had called on a number of friends before traveling to a area called the flapit were people took there off road vehicle's and motorbikes.

It was getting late and I had to be up for work the next day, so I made my way home as it was around 10:30 pm. I set off on my way back home. I was now on my way home, I was coming to a area I know well when I come across a strange tunnel in the road. Strange, I thought I have never seen this here before and I had only been down this road two days ago. The next thing I was been pulled in to the tunnel. The next thing I was in a darkened room. I could see movement in the room. I looked up and I could see what I could only describe as very tall monsters in the room, they was wearing blue uniforms some seemed to have a white apron on over the blue uniform. The next thing my head was moved forward and I seemed to have some thing injected in the back of my neck. The next thing I had my head moved forward and some thing put in my mouth then a tube put in to my mouth. The tube seemed to have a helmet attached to it.

Now I was sitting in what seemed to be a dentists chair with this helmet on my head. Now, I was taken up in the air and I was looking down in to what seemed to be an arena. There was a large screen in the arena with information coming up in it. At the same time the same information seemed to be coming up on to the helmets visor. The information seemed to be basic battle skills from a military manual. All the information needed to keep alive in a combat situation. There was even images of the different enemies, and the numbers of them, and the enemies allies along with their strengths and weaknesses. The next thing I was back on my motorbike riding back home.

I drove in to our back yard and parked my motorbike. I was putting the cover over my bike when I noticed the house lights were all off. Strange I thought! I tried opening the back door but it seemed to be locked. Now I started to wonder what was the time? Then my mother opened the back door she did not look happy. She asked me were I had been and did I know what time it was? I said no, my mother replied well its 2:00am, we have to get up for work soon. I did not tell my mum about what had happened to me till years later.

Q) You have been working on the Berwyn Mountains incident for over 26 years. The United Kingdom's Roswell is the Berwyn Mountains incident? Can you disclose anything about this case?

A) I come across the story about the famous Welsh UFO crash, AKA the British Roswell. The story had made the newspapers in Great Britian as well as around the world. There was a number of UFO groups researching the story back in the day. One group had a monthly magazine in 1974. There was a story written about the incident known as the Berwyn mountains incident. Over the years the story had made the television in a number of short documentaries.

It was after starting my own UFO group and advertising in local and national newspapers. I started to receive information about UFOs, aliens and abductions. I received a number of interesting letters about the Berwyn mountains incident. It was it this point that I decided at some point to make arrangement's to visit the Berwyn mountains in North Wales. I had become friends with a man and his wife from North Wales. They had seen a number of UFOs over the years. My friend Llewellyn from Wales had some amazing information about the Berwyn mountains incident and a story that was out of this world. I had made arrangements to meet up with Llewellyn and I had arranged to meet up with Llewellyn in two months. I was now at Llewellyn's home he had arranged a meeting with a group of five men who claimed to have come a cross a group of five aliens in a field and what looked like a flying saucer landed in the field also. The aliens were wearing what looked like grey silver pilot suits, like what you see on tv like alien greys, they seemed to be wearing a Sam Brown belt kit like what you carry a sidearm or weapon in.

Two of the Aliens seemed to be in pain as they were walking away from the landed craft, maybe the craft had crash landed and the aliens were injured. The group of men who were on their way home after being at a men's club were now parked at the side of the road looking at the crashed Alien craft and its occupants. Then there was a loud sound of heavy vehicles. The men were surrounded by military vehicles and now there was a soldier telling the men to get in the car and move off. The men got back in the car and made their way home.

I have spent the past 30 years researching this incident finding other witnesses and paperwork from the night of the 23rd January 1974. Over the years, I have required a piece of metal from a crashed alien craft and a piece of metal from a RAF Harrier jet that was said to have been shot down on the night of the incident. The group of men started their own research into their own close encounter for a number of years. It seems like the witnesses had been scared off. I was given research paperwork in the form of working maps of UFO sightings, and abductions along with what looks like battles with our armed forces.

Q) You have discussed with me about your first abduction and you talked about being in a dentist's chair and they inserted something into the back of your neck. Are you able to see this device in x-rays and have you ever found out what it was?

A) I never found out what the Aliens had injected in the back of my neck even though I have spent years in and out of hospital. I was diagnosed with M.E. by a specialist. A very strange thing when I have all of my medical records and on one letter my Dr wrote Mr Kellett is in a UFO Group. Why ?

Q) Take some time and tell us about your most memorable experiences being abducted by Aliens?

A) The most memorable experiences being abducted by Aliens is how we travel. Two crystal like balls appear on two pillow like objects and what seems to be power charges them up then the pillows move down to the floor leaving the two crystal ball like object hovering in front of me. I put my hands on top of the crystal ball like objects and I start to travel to the location that is shown in the visors on the front of the helmet that I wear.



Q) Can you talk to us about what kind of procedures these Aliens did to you? And have you felt any pain through these procedures?

A) When I am abducted, I find myself sitting down in what seems to be a dentist chair. At this point, I have my head pushed forward and it feels like I am injected in the back of my neck. I have vivid memories of being in the same chair that turns into a hospital bed where I am operated on. I feel lots of pain as I undergo what seemed to be an operation.

Q) What does the Alien spacecraft look like inside? Where and how were you kept there? And were you able to walk freely around the spacecraft?

A) The inside of the craft is smooth and silver. The craft turns from a ball like craft to a cigar like craft witch elongates to different size crafts. The crafts can travel under water also.

Q) Being abducted, how long did they keep you? And how much time was lost in life from being abducted to being sent back?

A) On the occasions that I have been abducted by the 15 feet tall human like Aliens I seem to have missing time. This is from one hour to an incredible three hours. In earth years that's from one year to three years.

Q) What kind of language did the Aliens speak? And where you able to understand them and what they were doing to you?

A) The Aliens are telepathic. It seems that most of the abductees are also telepathic, but they do speck in English to us.

Q) What kind of tests were done on you in these spaceships?

A) I don't remember tests as such. I remember having some kind of in plants inserted in my eyes, ears, and nose.

Q) Can you explain to us the feelings you felt as an alien abductee? And your most scared moment at that time?

A) When I am abducted I don't really notice. When I come around in a dark room and was looking around to see where I was, I noticed movement above me and as I looked up I saw the faces of the Aliens they looked like monsters. I was very scared.

Q) In these spaceships, were there other people abducted as well that you were able to see, or were you alone all the time?

A) When I was in the room after I was abducted I was raised up in to the air in the chair I was sitting in. I could see other people like myself in rows, all in lines. There was other abductees. I saw more abductee in the base were we lived.

Q) Take some time and share with us some of your experiences.

A) I am put in to an Alien army and trained as a super soldier. We fight the enemies of the Alien race that abducted us. There are many enemy Aliens and from Earth from other country's.

Q) 13) What did these Aliens look like? And was it the same species every time you were abducted or were there different ones?

A) I am not trying to show off saying I am a super soldier. Its what they turned me into. I don't like the fact I am taken with out permission. I did not ask for this. It's wrong.

What our Attempts to Communicate with Alien Civilizations say about us




From serious efforts to declare our presence to extraterrestrial civilizations to daft publicity stunts, we have been sending messages to space for decades.

What we do know is that most stars in our galaxy host planets, and that many of these are potentially habitable. This means there is a chance that at least one of those billions of planets is home to intelligent life. Those odds are sufficient to suggest we should try to say hello. Or at least that is the rationale for sending targeted radio signals into space. Over the past few decades, we have broadcast a mixed bag of signals, ranging from serious attempts to communicate with extraterrestrial civilizations to accidental broadcasts and daft publicity stunts. Put together, it makes for a slightly odd representation of us Earthlings.

Astronomers think that planets covered in water, with oceans hundreds of meter's deep, could be relatively common in our galaxy. Now the race is on to find one. It looks like there is nothing below the thick, hot clouds we are falling through. But descend a little further and the vista opens up to show an ocean as far as the eye can see. Its surface is steaming, feeding water vapor into the sky. Plunging into the waves, it is hot at first, but cools as we travel further into the darkness, the pressure becoming immense. We dive down hundreds of thousands of meter's until we reach the bottom where, instead of rock, the sea floor is made of ice. We have landed on a water world.

When astronomers began discovering planets outside our solar system in the 1990s, they realized that alien worlds come in an array of orbits, masses, sizes and compositions. These exoplanets couldn't be placed in simple rocky or gassy groups like those in our solar system. Some, it has even been suggested, could be 50 per cent rock and a whopping 50 per cent water. Send a spacecraft to a planet like this and the scene it would encounter may be similar to our imagined journey: a thick water vapor atmosphere shielding a vast ocean hundreds of kilometers deep, with an icy mantle below. It was long thought these water planets would be rare, if they existed at all. Fresh insights have led many astronomers to think they may, in fact, be relatively common and could be promising places to search for alien life.

Dr. George King, Contactee



The Aetherius Society

While Dr. George King is not the only person to have had contacts with beings from other worlds, he is definitely one of the most remarkable. He was indeed a rare individual, unique in the history of Earth.

He was chosen by the Cosmic Masters, advanced intelligences from other worlds, for his outstanding yogic abilities and dedication to truth. They designated him their Primary Terrestrial Mental Channel. He wasn't their only channel but he was their most important one. He was in communication with Cosmic Masters, beings from higher levels of existence on other worlds, from the time they first contacted him in 1954 through to his death in 1997.

During this time he received a vast amount of spiritual teaching from these intelligences in various ways including

by telepathy, and also by entering a positive samadhic yogic trance in which he allowed them to speak through him. The teachings given in this way are termed Cosmic Transmissions, of which there are more than 600. The audio recordings or transcriptions of many of these are available on this website. They cover a wide range of topics but there are some core themes running through them, the most prevalent being selfless service to others and that the Mother Earth is quickening her vibrations onto a higher spiritual frequency.

The spiritual teachings about UFOs on this website have come either from Dr. King directly or from the messages that he has channeled from Cosmic Masters who live on the higher realms of other planets, as well as Ascended Masters and unascended Earth people living on the higher realms of Earth.

Eventually King went public when he permitted the Master Aetherius to speak through him at a channeling held at Caxton Hall in London. He began the magazine *Aetherius Speaks to Earth* (now *Cosmic Voice*) and in 1956 founded the Aetherius Society. By this time the issue of UFOs had become a matter of public concern, and UFO contactees like King were offering an answer. Before the decade was out, King had attracted a following in the United States, and an American headquarters was established in Los Angeles.

King developed a picture of the cosmos as ruled by an extraterrestrial hierarchy similar to the theological spiritual hierarchy. The hierarchy sent spiritual energy to the planet, which could be used to fight the forces of evil, especially those coming from evil extraterrestrials. Spaceships position themselves above the earth at special times of the year, considered the best moments for transmitting the energies from outer space. King authored a series of books spelling out the theology and practices of what emerged as a new occult religion.

King claimed that he received a mystical consecration on July 23, 1958, from the Master Jesus for his mission; the Lord Buddha added his consecration on December 5, 1978. The society continues and has headquarters in both London and California, where it owns a complex of buildings.




